The show closes: at the latest 6:00 p.m.,

Cats must be healthy and free from infections and parasites. Vaccination certificates must be presented.

Vaccinations required: Feline Parvovirus and Cat flu (min. 15 days prior to the show, the first cat fluvaccination must be boosted). Rabies vaccination can be taken no later than 21 days before the import date. Validity of the vaccinations must be written in the vaccination certificate. Last day for vaccinations before the show is 19.01.2024 (rabies earlier). White cats must have a hearing certificate. Microchip is obligatory for all cats older than 10 months including house cats. All FIFe and Finnish Catclub (SRK) National rules apply.

Cage size: 65x65x56 cm, no double cages available. If you have your own cage, please inform the show secretary in advance. Bring your own cage decorations and sanitary equipment. The owners can themselves present their cats to the judges!

Entries are binding. Entries by email or late entries are not accepted. Please fill out a separate entry form for each cat and for each day. Corrections and changes in writing only to nayttelysihteeri@pohkis.fi

Amount of cats restricted to 160. Eventual elimination will be made based on date of arrival of the entry form.

Confirmations will be sent per e-mail.

If ten or more housecats is entered, one shorthair and one longhair housecat are chosen as best in show.

Attention!!! Show rules that are changed and will apply from 1st of January 2024, for example ages in classes 11 and 12, and also 9/10:

New ages valid for show classes 9 - 12 per 01.01.2024. As from the above date the ages valid as follows:
Cats, 4-8 months must be entered in class 12.
Cats 8-12 months must be entered in class 11.
Cats which already obtained certificates in class 9 or higher prior to 01.01.2024, will keep these certificates (and other awards achieved) and must be entered in accordance with the new age classification valid as from 01.01.2024. It is the cat's owner's responsibility to ensure that the cat is entered in the correct class.
